Community Garage Sale in June: Spring cleaning starts with the garage sale promoted by GMCA with print advertising and signs all over the hill. Clean out the garage.

Spring Cleanup: The Saturday after the garage sale weekend, GMCA procures dumpsters for conclusion of spring cleaning. Dumpsters are located at the Green Mountain United Methodist Church at the crest of the hill on Cedar Drive.

Landscape Photo Show: From Mother's day through Labor Day, the GMCA website features the yards and gardens on our hill with photos of properties nominated by our members. The hill is spectacular in the summer.

Annual Picnic: The first week in September features the GMCA Annual Picnic at Foothills Park (behind Foothills Elementary). Music, food and games make this another great occasion for the neighborhood to get together.

Fall Cleanup: The second weekend in September features a repeat of the dumpster cleanup at the church. Clean up for the coming fall and winter.

Annual Meeting: The first Thursday of October we hold the Membership Annual Meeting. At this time we elect the Board of directors for the coming calendar year, and raise issues of interest to the membership. In elections years, we invite candidates to present to the membership.

Santa Visits Foothills: GMCA sponsors a visit by Santa Claus to Foothills Elementary School. We furnish the school pictures of all of the children from kindergarten through third grade as they each talk with Santa. Santa has treats for each child.

<u>Holiday Lights</u>: In a fashion similar to the summer Landscape Event, our website features pictures of the decorations for the season. We feature Pro, Open and Sustainability recognition of our home decorations.

### **GMCA's Activities**

GMCA involves itself in several activities for our neighborhood which are not scheduled but go on throughout the year.

Neighborhood Watch: This is a cornerstone of our Neighborhood Awareness program described on our website. In direct cooperation with the Lakewood Police department GMCA provides help to neighbors who want to take the next step community security. This is very popular as one can see by the Neighborhood Watch signs found around the hill.

<u>Block Parties</u>: GMCA encourages block parties and contributes to them. This is a great way to generate neighborhood camaraderie and compliments the Watch.

Entrance Signs: GMCA invested significantly in the two Green Mountain Estate signs and garden located at the north and south end of Alkire Street. GMCA maintains these areas throughout the year with volunteers with a green thumb.

Adopt a Family: We are compelled to consider our neighbors in need. Typically near the holiday season, GMCA identifies families that have special needs including food, clothing and holiday gifts. Our neighborhood has proven to be very generous in contributing to this effort, and even directly adopting families.

### **Special GMCA Accomplishments**

Since 1981 GMCA has made some very significant contributions to our neighborhood regarding zoning, code issues, neighborhood safety and the like. Recently, a couple of special accomplishments stand out.

Foothills Field of Dreams: GMCA and Green Mountainside neighbors contributed significant time and money to the successful acquisition of a \$130,000 grant for the improvement of playground property at Foothills Elementary School.

Whiz Kids: GMCA is a very strong supporter of the Whiz Kids program at Foothills Elementary and the resulting rise in student scores.

**Mountainside Park**: GMCA was instrumental in the path, trees, signs and cleanup of Mountainside Park.
